Dear Parent/carers

Session Request Form 2026/27 academic year

You are invited to apply for sessions at the Brambles preschool from September 2026 (for children aged 3 before 1 September 2026) or once your child has become eligible for Early Years funding (the term after their 3rd birthday if it falls between 1 September 2026 and 31 August 2027).

The following sessions are available at Brambles:

9 am – 12 noon	Morning session
12 noon – 3 pm	Afternoon session (includes lunch)
9 am – 3 pm	Full day

Currently all 3 and 4 year-olds are entitled to 570 hours of government funded childcare per year – this is your **universal entitlement**. If you meet certain criteria, you may be eligible for an additional 570 funded hours – this is known as **extended entitlement**.

If you qualify for extended entitlement you can receive a total 1,140 hours of free childcare each year, which works out as 30 hours per week in a term-time only session like the Brambles Preschool.

Booking your sessions at Brambles

If your child qualifies for 30 hours free childcare, you can apply for sessions up to our maximum 30 hours each week.

If you are not eligible for the extended entitlement, you will still qualify for 15 free hours of funding, but extra sessions will have to be paid for. The hourly charge for 2026/27 has not yet been set but as a guide the current charge is £6.30 per hour.

Brambles policy is that each child attends a **minimum of four sessions** (12 hours) per week. This is to support your child settling and building friendships, and to support your child's learning and development. Please note that our Admissions policy gives preference to those children attending Brambles for at least five sessions (15 hours) each week.

You may split your hours across more than one setting, for example your child might attend different settings on different days, or if you need more hours of childcare than the Brambles Preschool can provide, you might choose to place your child with a childminder before and/or after our opening hours. If your child has attended a setting which offers care outside of term time (a stretched claim) then please be sure to let us know on your session request form as this will impact the number of free hours you can claim at Brambles over the year. If this is the case, you will be required to pay for any unfunded hours. No child may attend more than two settings in a day.

*Please note that your child will be unable to start Brambles until Parent/Carer Declaration forms are completed and returned to us. If you are entitled to extended hours, your HMRC code **must** be confirmed before the start of term, that is by 31 August 2026. We are required to verify all extended entitlement codes and, as Brambles is not open during the summer holiday, in practical terms codes need to be provided by 17 July. During the year you will have to renew your HMRC code before the start of each term to maintain your extended entitlement.*

We will endeavour to meet session requests, though the pre-school's current staffing allows for a maximum of 32 children at any one time. If we receive more requests for pre-school places than there are places available, the school will follow the procedures laid out in the pre-school's Admissions Policy to allocate sessions. As we will work to the sessions you have requested, please consider your requirements carefully. We may be able to offer only part of your request, or we might offer alternatives if your preferred sessions are not available. *However, this will be only after consideration of all eligible requests; if someone with a lower ranking has requested the available sessions, their request will be considered before alternatives are offered.* From previous experience, Friday and Mondays are our least popular days and if your requirements are not determined by working patterns you may wish to consider this when applying. Brambles Preschool will accept children with special educational needs, however such needs must be disclosed upon application as our ability to provide enhanced support depends on our having sufficient staff. Our highest priority is the safety of children in our care, and places may be withdrawn if disclosure of relevant information is incomplete.

Please note that if you are eligible for 30 free hours of childcare but opt not to take your full entitlement at the start of the year, you may not be able to increase your hours later if Brambles is fully booked. While we understand that circumstances change and you may wish to request changes after your place is confirmed, please note that if we cannot accommodate a request the place may be withdrawn.

Please return the Session Request form to Brambles pre-school by **12 noon on Friday 17 April 2026** in order to be included in our first round of allocations.

Confirmation of Places will be sent out from **Friday 1 May 2026**. **Please confirm acceptance as soon as possible, and by 12 noon on Friday 15 May at the latest. If we have not heard from you by the end of that day we will assume that you no longer require the place.**

Funding forms, agreement of terms and conditions and admissions forms should then be returned to Brambles by **12 noon on Friday 22 May 2026**.
