

Primary PE and Sport Premium Funding 2024/25

Background:

The Government have provided funding for Physical Education (PE) and sport to schools. This funding must be used to improve the quality and breadth of PE and Sport provision. The funding is for the period 1 September 2024 – 31 August 2025. The funding is ring fenced to be used for sport specific areas to make a sustainable impact in Physical Education and Sport in schools.

Schools are free to determine how best to use this funding to improve the quality and breadth of PE and Sport provision, including increasing participation in PE and Sport so that all pupils develop healthy lifestyles and reach the performance levels of which they are capable.

The vision for the Primary PE and Sport Premium is:

All pupils leaving primary school physically literate and with the knowledge, skills and motivation necessary to equip them for a healthy lifestyle and lifelong participation in physical activity and sport.

OBJECTIVE: To achieve self-sustaining improvement in the quality of PE and sport in primary schools.

It is expected that schools will see an improvement against the following 5 key indicators:

1. *The engagement of all pupils in regular physical activity – kick-starting healthy active lifestyles*
2. *The profile of PE and sport being raised across the school as a tool for whole school improvement*
3. *Increased confidence, knowledge and skills of all staff in teaching PE and sport*
4. *Broader experience of a range of sports and activities offered to all pupils*
5. *Increased participation in competitive sport*

For the academic year 01 September 2024 – 31 August 2025 the DfE has required reporting of expenditure and outcomes using a digital form. The submissions made via this form can be found at the end of this report.

The tables below provide some detail on how the school spent the funding.

CPD – external coaches supporting confidence and competence £12,650

Activity: Employing a PE specialist teacher from the Hunts Schools Partnership to team teach alongside teachers to raise standards within Physical Education and Sport for the whole academic year. (38 weeks of a full day working alongside class teachers). This supports staff to have increased knowledge, skills and confidence to teach physical education to children and young people.

Impact / Rationale for spend and desired outcomes: To raise the quality of teaching in Physical Education and Sport. Develop knowledge, skills and confidence to teach the whole child through physical education and school sport. To increase pupil participation in a range of inclusive activities.

A broader experience of a range of sports and activities are offered to all pupils.

The profile of PE and School Sport is raised across the school as a tool for whole school improvement.

Staff has increased knowledge and can teach high quality physical education in a range of activities appropriate to pupils' age groups.

Sustainable activity through staff continuous professional learning leading to continued delivery of high quality physical education.

Monitoring/ Evidence: Increased confidence of staff in delivering high quality PE lessons across the school. This has been evidenced through observations and feedback from staff is that they have developed their skills and knowledge of the PE curriculum. Model lessons have been taught which staff have then adapted and developed to extend skills

CPD – Internal learning and development - £880

Activity: PE Coordinators – management, planning and organisation of whole school Physical education including competitions. Monitoring participation and planning. Release time off timetable. Attendance at PE leaders' meetings.

Impact/Rationale for spend and desired outcomes: Provide the PE coordinators with time to undertake an audit of our provision, produce an action plan for PE and organise teams, training and activities across the school.

Monitoring and evaluation: The PE coordinators created a coherent structured action plan and monitored implementation without this impacting on their teaching roles.

Internal Activities – top up swimming lessons - £2,670

Activity: Provision of booster swimming lessons to children in Year 6 who were unable to swim 25m.

Impact/Rationale for spend and desired outcomes: Increase the number of pupils able to swim 25m

Monitoring and evaluation: All children participating in booster swimming lessons improved their ability to swim, with some achieving the target of 25m.

External Activities – organised by school games organiser network - £3,860 and other inter-school sports competitions - £70

Activity: Cost of transport to sporting competitions and fixtures. Cost of HSSP core offer (giving access to a broad range of competitions). Cost of releasing staff to accompany children to competitions.

Impact/Rationale for spend and desired outcomes: Increased participation in competitive sport

Monitoring and evaluation: Increased number of children competing in sports including football, cross country, tag rugby, gymnastics, cricket, hockey, netball, NFL, athletics and panathlon. Participation in girls' football competitions.

External Activities – external coaching staff - £1,050

Activity: Delivery of extra-curricular clubs at lunchtimes and after school to boost opportunities for pupils to participate and increase physical activities.

Impact/Rationale for spend and desired outcomes: Increased opportunities for pupils to participate in a broad range of extra-curricular sporting activity.

Monitoring and evaluation: Clubs delivered throughout the year by external coaches, to supplement the clubs run by school staff.
